Fire Chief's Report

Statistics. In the month of February 2012, Rye Fire responded to 45 calls for service of which 34 were EMS related and 11 were fire related. In comparison with previous year this is a 27% increase from 2011 and a 17% increase from the five year average of 38.

Employee Changes. Mid February 2012 Rye Fire Protection District encountered significant personnel changes.

Through this process Rye Fire has been able to adequately respond to emergencies throughout the District as well as provide Mutual Aid to Pueblo County Emergency Services.

We have hired additional part-time employees. We currently have 6 Paramedics, 3 Intermediates for a total of 9 ALS responders and the remaining 7 are EMT's providing a total active roster of 16 employees.

Prevention. Rye Fire personnel participated with fire drills at Rye Elementary School and Craver Middle School.

Major Events. Waco Mish Fire. On March 3, 2012 Rye Fire responded to a structure fire on Waco Mish. A male party was rescued from the burning home as he was trapped and unconscious; he was taken to a Pueblo hospital and flown to Denver. The fire was extinguished.

Burnt Mill Road Fire. March 3, 2012 Pueblo County requested mutual aid assistance for a structure fire on Burnt Mill Road. Rye Fire responded with Water Tender 12.

Old Business

East / West Hatchet Inclusion Update

Ms. Eiland noted the Board had delegated the handling of the election to the Pueblo County Clerk and Recorder. Due to a number of reasons, Pueblo County has declined to conduct the election. Mr. Steve Bennett will work with Ms. Eiland to conduct the election.

New Business

Sterling InfoSystems

Mr. Jim Beach noted at the request of the Board, Rye Fire contacted our insurance carrier who works closely with Sterling InfoSystems for background checks. All new and existing employees will undergo a criminal background check, driver's license check, social security check, workman's compensation check, and drug screening. The board needs to approve this company in order to initiate this program. This company was recommended by our insurance carrier, VFIS. This company will handle the necessary paperwork to stay in compliance. The estimated cost per person is \$60-70 per person plus drug screening. Sterling is worldwide and currently does all checks for Denver Fire, Denver Police and Denver County Sheriff.

Transitional Employee Bonus

Motion to provide bonuses for those employees's who worked during the transition as a thank you during this period. Fire fighter bonus will be \$250 per person for five (5) and Command Staff will be \$500 per person for three (3). Total bonus amount is \$2,750 will be on the next pay cycle.
