### Treasurer's Report

Chief Bennett noted that he sent an E-Mail out regarding Line 7740. (Note it was sent 10/21/2014) This line includes the ambulance purchase (\$147,065), Med 21 engine (\$19,839.37), and Tahoe purchase (\$33,821.61). The reimbursements, where applicable, are in other line items. Question arose as to why certain taxes are over 100%. This is due to people paying previous years taxes this year. Lines 4510, 6113, 6115, and 7221 will be pulled from the first report since they pertain to Interagency Firefighting and are on a separate report. Mr. Davis is going to contact E-23's leasing firm to investigate moving the payment date from December to March/April as this is when cash flow is greater than at the end of the year.

It was noted that this year's Ambulance Receipts are in line with projected budget for this year. The EMA in-district letter was reviewed with no proposed changes. Mr. Schaiberger noted that he received a complaint that he received from a former patient about a couple bills they received. Captain Beach will research and advise the board.

### Fire Chief Report

**Statistics.** In the Month October 2014, Rye Fire responded to 65 calls for service of which 50 were EMS related and 15 were fire related. In comparison with previous year this is an increase of 8% from 2013 and an increase of 23% change from the 5 year average of 53.

**Administration/Operations.** A new grant is being prepared. We are receiving some guidance from a couple other departments on the preparation of the grant. This grant is specific to bunker gear and personal protective equipment. The new grant that the State will be opening will focus on personal protective equipment as well and is their top priority.

Repairs to the fire station are nearly complete. The construction company is waiting for warmer weather to get the rock back on the building.

Crews painted the face front of the Station in Colorado City. They obtained donated paint from a paint store in Pueblo. Crews are also in the process of installing a flag pole in the front of the Station in Colorado City. All parts and pieces were donated for the project.

Researching other available grants, another grant that is being pursued is the SAFER grant which is funded through FEMA this grant has not yet become available.

Rye Fire will be part of a county wide grant with other departments to purchase new SCBA harnesses packs and cylinders as nearly all cylinders in Pueblo County are expiring.

Numerous Grants are being researched to purchase personal protective equipment.

**Prevention.** We continue to provide Mitigation assessments for various homeowners throughout the District.

Provide assistance to School Dist 70 for fire drills and all hazard drills.

Crews went to Rye Elementary for Red Ribbon week and had lunch with all grades in the school.

**Training.** Training has been ongoing throughout the month. Fire training covered vehicle extrication, rope rescue, and map training. EMS training is ongoing with a new topic every 6 days concerning procedure changes, protocol changes and continuing education.

**Other.** Mr. Shaiberger asked, for the record, that a paid grant writer be retained by the District to assist in writing grants, which was accepted by all.

Donation of paint was questioned. Local businesses were asked for donations but unable to fill the donation request. Chief Bennett noted that Sherwin-Williams from Pueblo donated the paint and staff completed the work. The Board requested that Sherwin-Williams be sent of letter of thanks.

Chief Bennett reported that his new Tahoe was struck and damaged while parked on an incident on I-25 during the recent snow storms. A person was passing illegally and lost control striking the right rear of the vehicle on icy roads. No staff was injured. Rye Fire insurance has been notified and is starting the insurance claim so that repairs can be completed in a timely manner.

## Old Business

### Hatchet Ranch Updates

Mr. Elliott reported that two (2) temporary boxes have been placed on two of the tanks, but valves are still a freeze concern. There is still concern about freezing and will be researched further. There has been about 12” of settlement on the north tank on the West Hatchet site. This is because the tank is on a slope and compaction is not an option. The tank does not appear to be any danger of movement and will be addressed when the weather cooperates. It was reported that the military flew to the Huerfano County site, but did not move the large tank. The military is looking some logistical issues.

### Disposition of Equipment

Chief Bennett noted that he received an offer of \$800 for the old chief truck. Board instructed Chief to accept. Chief Bennett noted that the City of Pueblo has offered \$15,000 for the third time for the Peterbuilt. The Board asked if the item has been previously posted in the paper and it was noted that it had not.

Motion to advertise in the local paper the sale of the Peterbuilt with a minimum bid of \$15,000.

Mr. Schaiberger gave his marked up copy to the Chief.

The Board went through the revised personnel policy from MSEC page by page for about two-thirds of the handbook. The final portion will be reviewed at next month's meeting.
